- 2. Bidder who chooses to submit their bids or quotation electronically may download the bidding documents for e-submission from PPMO's e-GP system <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a>. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below. Bid security amount of the electronic bid should be as mentioned on the table below for each bid and the eligible bidder should submit the original voucher with bid document or submit equivalent bank guarantee from Commercial Bank or Financial Institution eligible to issue Bank Guarantee as per prevailing Law having validity period of 120 days in the following Security deposit (Dharauti) account as specified below.

- 4. Pre-Bid meeting shall be held at 11:00 AM, 2082/09/20 (4th January, 2026) at the Vyas Municipality Office, Damauli, Tanahun.
- 5. Electronic bids must be submitted to the office Vyas Municipality Office, Damauli, Tanahun through PPMO website www.bolpatra.gov.np/egpon or before 12:00 PM on 2082/09/30 (14th January, 2026). Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM, 2082/09/30 (14<sup>th</sup> January, 2026) at the Vyas Municipality Office, Damauli, Tanahun. Bids must be valid for a period of 90 days and must be accompanied by a bid security, amounting to a minimum of mentioned below, which shall be valid for 30 days beyond the validity period of the bid (i.e 120 days for bid and 105 days for quotation)
- 7. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 8. The bidders who submitted their bids electronically through e-procurement section of PPMO's website <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> may submit hard copy of not later than 8 days of the opening of bids, i.e.; before <a href="2082/10/06">2082/10/06</a> (20th January, 2026).
- 9. The Employer reserves the right to accept or reject any or all the bids without assigning reason, whatsoever.
- 10. Any intimidation, collusion and curtailing during bidding process shall be punishable by law.
- 11. Other matters regarding the bidding process should be as per prevailing law of Government of Nepal.
